What is BESC in Senegal?

What is BESC? The BESC, or Electronic Cargo Tracking Note, is a mandatory document for all cargo shipments to Senegal. Introduced by the Senegalese authorities, the BESC ensures that comprehensive information about the cargo is provided before it arrives at the port.

What is ECTN in Senegal?

703 Evans Avenue Toronto Canada M8Z 1H4 The ECTN is a document which is required for all shipments of cargo to Senegal. It is obtained from the shipping company and must be presented to Senegalese customs upon arrival of the shipment. Every shipment having Dakar as its final destination has to be protected by an ECTN or BESC.

What is a cargo tracking note (CTN) in Senegalese?

It is bordered in the North by MAURITANIA in the East by MALI and in the South by GUINEA BISSAU and GUINEA CONAKRY In 2008, the Senegalese Shipper's Council established the requirement that all cargo imported into the country will require a Cargo Tracking Note (CTN). Some shipping lines may not load cargo without the CTN number.
