Do inverters export more than a set kW limit?

Inverter configuration or commissioning setting Most modern inverters support a fixed export limit setting that's applied during commissioning. For simple static limits this is often the easiest and cheapest method -- the inverter simply never exports more than the set kW limit. This approach is common in small residential installations.
